Nessebar 2025

X International Festival "NESSEBAR - ISLAND OF ARTS" - 2025 will be held with the participation of ensembles, creative collectives, choirs, formations and performers from Bulgaria and other countries.

The Municipality of Nessebar, Municipal Children's Complex – Nessebar are the organizers of the competition.

Children and youth from all over the world can participate in the X International Festival "NESSEBAR - ISLAND OF ARTS" - 2025. All young people have the opportunity to show their qualities and talents. Nessebar - a city of world cultural heritage will become a big scene of the arts.

We hope that the meeting of history and art will inspire and illuminate many new talents, and a special atmosphere to be created by the meeting of different cultures, traditions, religions.

The festival is organized annually from July 2 to July 6 in Nessebar, Republic of Bulgaria.

Conditions for holding the festival

Collectives, chamber formations, ensembles and solo performers can take part in the festival.

Competition sections:

- Vocals;
- Choreography.

Age categories:

- I group – junior age group - those born from 2011 to 2014 inclusive
- II group - middle age group - those born from 2007 to 2010 inclusive
- III group - senior age group - those born from 2004 to 2006 inclusive
- IV group - senior age group - those born before 31.12.2003.

Competition sections, categories

"Vocal" section

Categories:

- a) **folk song**- soloists and ensembles;
- b) **classical singing**– soloists and ensembles;
- c) **entertaining and pop song** - soloists and ensembles.

"Choreography" section

Categories:

1. **National Dance:**
 - a) finished folk dance;
 - b) authentic folk dance;
 - c) stylized folk dance.
2. **Typical dance** - stylized stage forms of folk dances, oriental dance.
3. **Modern dance** - performances of this category can be in the styles:
 - a) jazz dance;
 - b) modern dance /contemporary/;
 - c) graham;
 - d) disco;
 - e) free dance /mixing of styles from this category is allowed.
4. **Street styles /street dance/** - performances of this genre category must be sustained in the style of urban dance and include all styles:
 - a) Hip-Hop;
 - b) Break dance;
 - c) New Style;
 - d) Locking&Popping;
 - e) Krumping;
 - f) Clown dancing;
 - g) Free dance (from that category), etc.

Conditions for participation in the competition sections

VOCAL Section

Collective and individual performances

1. Performances in the "Vocal" category are live with musical accompaniment or backing vocals of the participant's choice.
Playback and dubbing of the soloist is not allowed.
2. Vocal formations are composed of at least two participants.
3. Formations in which performers from several age groups participate compete in the age group of the oldest participant.
4. Participants in the category "Entertaining and pop song" perform two songs, one of the performances must be in their native language.
Only one performance in a foreign language is allowed.
Duration: up to 5 minutes per song.
5. For participants in the "Folklore song" category:
 - Participants perform two folk songs.
 - The accompaniment can be with synback or live.
 - The participants of the 1st and 2nd age groups perform two fast folk songs, and for the 3rd and 4th age groups one slow (non-measured) folk song and one fast folk song are required.

CHOREOGRAPHY section

Collective and individual performances

I. "Folk Dance" Category

Dance folklore groups – ensembles, formations, chamber groups.

1. Authentic folk dance;

2. **Finished folk dance** – national folklore from the country of the performers;

3. Stylized folk dance:

- under folk music;

- folk choreography to modern music with stylized folk costumes and costumes.

Number of participants:

- in chamber dance groups - up to 8 people
- in dance ensembles and ensembles without restriction.

Duration: Chamber groups to present a program of up to 8 min;

Dance ensembles up to 15 min;

Ensembles up to 20 minutes.

Recommendations: Chamber dances should have a thematic or plot form.

II. "Typical dance" Category

The choreography has the character of folk dances of everyday life from different nationalities belonging to the genre category.

III. "Modern dance" Category

Performances in this category can be in the styles: jazz dance, contemporary dance, graham, neo classical, etc.

IV. "Street dance" Category

Performances from this genre category must be of high artistic merit in the style of Hip-Hop dance and can include all styles of street dance: New Style, Free dance, Locking & Popping, Krumping, Clowndancing, Break dance, etc.

Individual performers participate with one dance in a relevant genre category and age group. The duration of each dance should not exceed 2 minutes.

The competition program is conducted as follows:

National competition - "NESSEBAR - ISLAND OF ARTS"

International competition - "NESSEBAR - ISLAND OF ARTS"

Those wishing to take part in the competition should fill in the **Application for Participation /according to the organizer's template/** by June 5, 2025 and send it toe-mail: festivali@nesebar.bg или odk@abv.bg

The application should be sent in Word format. It should not be scanned or in pdf format.

1. The participants present in the competition 2 /two/ performances with a maximum duration of 5 minutes each in each applied style of nomination, **if no other requirements are specified in the conditions of the specific nomination.**

2. Individual participants can compete in a maximum of two nominations.

3. The leaders of the groups bear a responsibility:

- for accidents and injuries to performers on stage;

- for the behavior of the group members during the events of the festival.

4. Participants are responsible for their own costumes, props and personal belongings.

5. The music for each performance should be on a **USB Flash memory stick containing only music for the performances.**

6. The same performance that competes in a given style and age group is not eligible to compete in another style of competition.

7. The expenses for the residence of the groups and their accompanying persons regarding travel, daily and overnight expenses are at the expense of the participants.

8. Formations in which performers from more age groups participate in the age group of the oldest participant.

9. Organizers reserve the right to photograph, film, record and distribute execution from the competition program without paying rights and benefits.

10. The schedule for the order of performance is determined by the organizational committee **5 days** before the start of the competition. **Changes are not allowed.**

11. It is a jury right to determine which award -winning participants will be presented at the Gala Concert.

12. On July 1st and 2nd, the organizers hold technical conferences with group leaders.

13. The nomination and award ranking will be carried out on 06.07.2025 on a schedule determined by the organizers.

14. The event organisers provide transportation only for the opening and closing of the festival. On the days of the competition the participants need to find their own means of transportation to the festival stages.

AWARDS

The ones who take I, II, III place in each nomination and age group receive a diploma, plaque or medal.

Each group and individual performer receives a diploma for participation.

The jury awards a great award - the Grand PrX for each section: vocal and choreography.

Special Prizes are presented by Nessebar Municipality and Municipal Children's Complex - Nessebar.

Financial conditions

(1) National Contest "Nessebar-Island of Arts"

- for groups (all sections) - 20.40 BGN (with VAT) for each participant;
- for individual participation - 60 BGN (with VAT).

(2) International Competition "Nessebar-Island of Arts"

- for groups – 42 BGN (with VAT) for each participant;
- for individual participation – 60 BGN (with VAT);
- In case of individual participation and participation in a group, the fee is BGN 60 (with VAT).
